

FY 2016 SIF Classic Notice of Funding Availability (NOFA) Fact Sheet

What Is The Social Innovation Fund (SIF)?

The Social Innovation Fund (SIF), a program of the Corporation for National and Community Service (CNCS), combines public and private resources to grow the impact of innovative, community-based solutions that have compelling evidence of improving the lives of people in low-income communities throughout the United States. The SIF invests in three issue areas: economic opportunity, healthy futures, and youth development. The SIF makes grants to experienced grantmaking institutions that are well-positioned within communities to identify the most promising programs and guide them towards greater impact and stronger evidence of success. In addition to funding, Social Innovation Fund recipients receive significant technical assistance to support implementation and evaluation of their innovative programs.

Who Can Apply?

This competition is open to existing grantmaking institutions (organizations that provide grants to nonprofits as an essential means of fulfilling their mission) or eligible partnerships (between a grantmaker and a State Commission on National and Community Service, or a chief executive officer of a unit of general local government with the partner organizations sharing responsibilities under the award). Current SIF Classic recipients may apply for new interventions; however, previous funding from CNCS or another federal agency is not a requisite to apply.

What Are We Looking For?

The SIF seeks recipients who will run open competitions to select, fund, support, and evaluate community-based nonprofit organizations to grow promising, innovative approaches to overcoming challenges facing local communities in our three issue areas:

- Youth development Preparing children and youth for success in school, active citizenship, productive work, and healthy and safe lives, including crime reduction initiatives focused on juvenile delinquency and victimization prevention and response,
- **Economic opportunity** Increasing economic opportunities and financial stability for economically disadvantaged individuals and families, and
- **Healthy futures** Improving health outcomes, promoting healthy lifestyles, and decreasing health disparities that disproportionately affect low-income communities.

Within these issue areas, there is a special emphasis this year on three funding priorities: *Juvenile Justice* - Strategies to improve outcomes for youth involved in, or at risk for involvement with, the juvenile justice system. *Technology* - Strategies to utilize technology to increase the impact of the proposed evidence-based social programs. *Early Childhood Education* - Strategies to expand access to high quality early learning education for children through age five that prepares them for lifelong success.

What Are The Funding Amounts?

The SIF will award up to \$39 million in grants for its Classic Program during the 2016 fiscal year. Each selected recipient

will be awarded between \$1 million and \$10 million annually and will be required to match every federal dollar of the grant award in cash. A majority of awarded federal funds must be invested in subrecipient programs.

Why Should You Apply For A Social Innovation Fund Grant?

We all know that progress on our social challenges has been too slow and limited resources have been spent on approaches that do not work. We need innovation that will help achieve faster, longer lasting progress, as opposed to marginal or incremental progress on our social problems. We must help effective organizations grow their impact and transform more lives by investing in cost-effective, evidence-based approaches that lead to better results for the public good. The SIF is designed to help funders who share these beliefs by significantly increasing resources and attention to this important work, and supporting evaluation and expansion efforts through government funding and a robust network of peers. SIF recipients are a part of the leading edge of high-performing, impact-oriented grantmakers that are serious about disrupting the status quo and accelerating solutions that work.

How Do You Apply?

STEP 1 – GET FAMILIAR:

The Notice of Intent deadline is April 15, 2016 and the Application deadline is May 10, 2016 at 5:00 p.m. Eastern Time.
