Subject: FY 2023 Annual Conference Report

As part of the government-wide effort to expend resources more efficiently and effectively, the 2023 Consolidated Appropriations Act (Pub. L. No. 117-328) directs federal agencies to submit a report to their Inspector General on conferences hosted for which the cost to the government exceeded \$100,000 for the previous fiscal year by January 31 each year. See also Continuing Appropriations Act, 2024, and Other Extensions Act, Pub. L. 118-15 (continuing appropriations through November 17, 2023). See also Further Continuing Appropriations and Other Extensions Act, 2024, Pub. L. 118-22 (further continuing appropriations for AmeriCorps through February 2, 2024).

In FY 2023, AmeriCorps sponsored three conferences that cost \$100,000 or more to advance or implement the agency's mission: the AmeriCorps Seniors Convening, the AmeriCorps Tribal Grantees Convening, and the AmeriCorps VISTA Sponsor Convening. The agency looks forward to continuing to work together to make these events as productive and cost-effective as possible to advance AmeriCorps' mission and make a difference in communities. The agency appreciates the Office of Inspector General's participation in these events.

Name of Event: AmeriCorps Seniors Convening

Purpose: The purpose of the AmeriCorps Seniors Convening is to provide a training opportunity for AmeriCorps Seniors grantees. This convening was the first in-person event AmeriCorps Seniors has hosted since 2019. The event served the recipients of AmeriCorps Seniors approximately 1,200 grants across the country, providing opportunities for training, technical assistance, and peer learning opportunities.



The 2023 AmeriCorps Seniors Convening theme was Growing Together: Uniting America Through Service. Throughout the convening, grantee representatives could attend inspiring plenaries, participate in breakout sessions, and hear from AmeriCorps' leadership and some of the agency's partners. The agenda allowed attendees to learn from national service experts, engage in meaningful discussions, share knowledge, make new connections, and gain valuable insight from their peers. In addition to the in-person sessions, AmeriCorps live-streamed plenaries and critical sessions. AmeriCorps Seniors will post all session materials on AmeriCorps' Learning Management System for access by grantees and agency staff.
