Dear ARP Volunteer Generation Fund grantees,

Welcome to the start of your grant period and, for some of you, welcome to AmeriCorps! We hope your VGF projects have gotten off to a great start this month and look forward to hearing about your accomplishments in the coming months.

As you may know, VGF is now housed under the new Volunteer Initiatives program office, which oversees AmeriCorps VGF and Days of Service grants. Our program staff consists of Emily Stock, who started as Project Manager for Volunteer Initiatives in May, and Zoe Goldenberg-Hart, who started in January as Volunteer Initiatives Grant Specialist. You can expect to see more communications from our office over the course of your grant with resources and programmatic support, and we look forward to working in partnership with you. By now you should also be acquainted with the Office of Regional Operations staff supporting your grant; please direct all questions throughout your project to your Portfolio Manager.

Program updates:

- As you continue to launch your VGF project, please make use of the VGF New
 Grantee Checklist attached to this message. The checklist is meant to guide you
 through the steps of setting up your project for grant compliance and includes links to
 other useful resources and eCourses that may help direct you.
- Please note that the <u>Grantees & Sponsors</u> resources page on the AmeriCorps website
 does not currently have a page for VGF. We are working to launch one in the next few
 months that will serve as a hub for resources specific to your VGF project. We will
 notify you once the page is up and running; in the meantime, refer to the <u>Manage</u>
 <u>Your Grant</u> page for general resources or contact your Portfolio Manager for specific
 guidance.
- VGF grantees were invited in February to attend a virtual briefing on the National Partnership for Student Success (NPSS). The <u>session recording</u> is available online, and slides from the presentation are attached to this email. Grantees supporting NPSSrelated activities are encouraged to <u>seek technical assistance</u> through the NPSS Hub or <u>become NPSS supporting champions</u>.
- As your project progresses, we want to hear the inspiring stories that come out of it!
 The reach of VGF goes far beyond what can be captured quantitatively, and we are always looking for stories that showcase the broad impact of VGF projects. Agency updates:

- We encourage you to check out the <u>Volunteering and Civic Life in America research</u> put out by the AmeriCorps Office of Research and Evaluation in January of this year. The office kicked off a four-part webinar series called *Reigniting Civic Life* in March with the session "What is Civic Engagement? Exploring New Paradigms." <u>Register here</u> for the second session, "Community-Based Research as a Vehicle for Civic Engagement and Community Impact," on Wednesday, April 26, 3:30-4:45 p.m. ET.
- You should have received a <u>memorandum</u> on March 10 from our Office of Grants Administration notifying you of the elimination of the Payment Management System (PMS) Federal Financial Report (FFR)/Federal Cash Transaction Report (FCTR) quarterly filing requirement. As a reminder, you will still have to file an FFR/FCTR covering the period from January 1 to March 31 **no later than April 30.** That will be the last FFR/FCTR you are required to file in PMS.
