Since 1994, more than 34,000 Maryland residents have served approximately 49 million hours and earned education awards totaling more than \$126.2 million.

Completed participants reflects all AmeriCorps members who completed service in Maryland between February 23, 2024 and February 21, 2025. For AmeriCorps Seniors, this reflects all volunteers funded by grants completed during that same period. For AmeriCorps Seniors projects where 2024 service location data is unavailable, service locations associated with the project from the previous year are represented or are listed with no service locations. 4. The Education Awards figures represent the maximum potential value of Segal AmeriCorps Education Awards that could be earned by AmeriCorps members who completed service in Maryland. 5. AmeriCorps State and National, Foster Grandparent, and Senior Companion federal funding reflects the estimated proportionate annual share of the federal grant associated with the participants in this report.
